PARCEL 1:

That part of Lot 1, together with Lot "A" taken as a tract, said Lot being in Tchuster and Kruger's Subdivision of part of the South Half of the West 20 acres of the East Half of the Northwest Quarter of Section 15, Township 41, Range 13 East of the Third Principal Meridian, and said Lot 'A' being in Terminal Park Subdivision, being a subdivision of part of said Lot 1 in Schuster & Kruger's Subdivision aforesaid described as follows is inning at a point on the southeasterly line of Gross Point Road 90.01 feet northeasterly of the point of intersection of the said southeasterly line of Gross Point Road with the east line of Niles Center Road; there southeasterly perpendicular to the said southeasterly line of Gross Point Road 120.05 feet to the southwesterly corner of said Lot "A"; thence no theasterly along the southeasterly line of said Lot "A"; thence no theasterly along a line perpendicular to the said southeasterly line of Gross Point Road 120.05 feet to the said southeasterly line of Gross Point Road 50 feet to the said southeasterly line of Gross Point Road 50 feet to the point of beginning (except the northwesterly 78.33 feet of the aforesaid described property), in Cook County, Illinois.
