Title to all streets has been reserved and dedicated for public use.

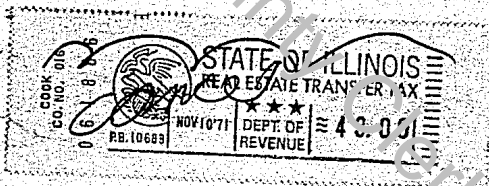

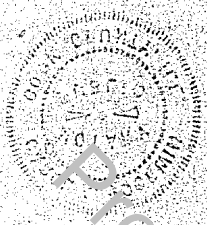
