- 1. It is distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings; it clud is all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute seculed it detected the sale of the proceedings is closely additional to that evidenced by the note hereby secured, with interest thereon as herein provided; third, all principal and interest them, ning unpaid; fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear.
- 9. Upon or at any time after the filing of a complaint to foreclose th' Tru t Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after 'ale, 'ithout notice, without regard to the solvency or insolvency of Mortagons at the time of application for such receiver and without regard to 'e 'e n value of the premises or whether the same shall be then occupied as a homesteid or or provided the rents, and the trustee hereunder may be appointed as uch receiver. Such receiver shall have power to collect the rents, issues and profits of said premise during the pendency of such foreclosure suit and 'case of a sale and a deficiency, during the full statutory period for redemption, whether the such period for a well as during an 'arrher time,' hen Mortagons', except for the intervention of the profection, possession, control, management issues and profits, and all other powers nich any be necessary or are usual in such cases for the profection, possession, control, management of operation of the premises during the vole of aid period. The Court from time to time may decree foreclosing this Trust Deed, or any tax, special assessment in whole or in part of: (1) The indebtedness secured-hereby, or by any decree foreclosing this Trust Deed, or any tax, special assessment or other lien which may be "to come superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of so', a deficiency.
- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof st. Il east bleet to any defense which would not od and available to the party interposing same in an action at law upon the note hereby secureu.
- 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable intended for that purpose.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactor evid acromatic individual secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and an expert of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all it be after by secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be a prior trustee the retunder or which conforms in substance with the description herein ontained of the principal note and with urports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee at the principal note described any note which may be presented and which conforms in substance with the description herein described any note which this instrument identifying same as the principal note described herein, he may accept as the genuine print in note herein described any note which this instrument identifying same as the principal note described herein, he may accept as the genuine print in note and which purports to be executed by the persons herein designated as makers thereof.
 - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have
- been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.
- 15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or thro Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the paymen the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
