Merrion's Country Club Hills First Addition, a subdivision of the Southeast quarter of the Northwest quarter (except the East 50 feet of the South 165 feet thereof) and the East half of the Southwest quarter (except the East 50 feet thereof and except the West 262 feet of the South 450 feet thereof) of Section 34, Township 36 North, Range 13, East of the Third Principal Meridian, according to the plat thereof recorded September 26, 1956 as Document #16709687 in Cook County, Illinois.

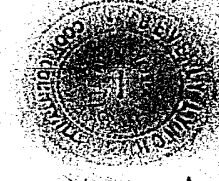
