 described tract.

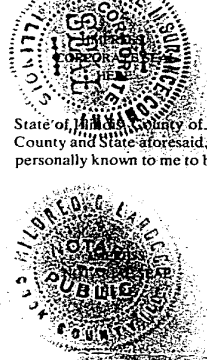
