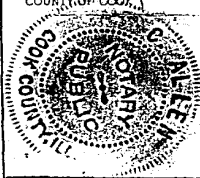

GRANTOR ALSO HEREBY GRANTS TO THE GRANTEE, THEIR SUCCESSORS AND ASSIGNS, AS RIGHTS AND EASEMENTS APPURTENANT TO THE PREMISES HEREBY CONVEYED, THE RIGHTS AND EASEMENTS SET FORTH IN THE AFOREMENTIONED DECLARATION OF CONDOMINIUM OWNERSHIP, IN THE DECLARATIONS RECORDED AS DOCUMENT NOS. 21712318 AND 21712320 AND AS SHOWN ON THE ABOVE DESCRIBED PLAT RECORDED AS DOCUMENT NO. 21704184.
