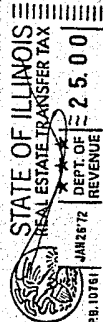
FRANCISCO QUINTANA and ROSARIO QUINTANA, his wife, not as tenants in common, but as joint tenants, parties of the second part.

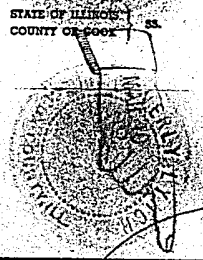
