## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED).

1. Mortgagirs shall (1) prumptly repair, resture or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from nechanic's or tother liens or claims for lien not expressly subordinated to the lien hereof, (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (4) complete within a reasonable time any building or building no wor at any time in process of erection upon said premises; (5) comply with all evidenments of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except a required by law or municipal ordinances with respect to the premises when due, and shall, upon written request, furnish to Trustee or to holders of the rote duplicate receipts therefor.
