This Deed is executed by the party of the first part, as Trustee, on aforesaid, pursuant to and in the exercise of the power and authority given to it in the instrument of creation of Deeds in Trust and the provisions of said Trust Agreement above mentioned, and of every other power and authority thereto enabling. This Deed is made subject to the law of all trust deeds and/or mortgages upon said real estate, if any, recorded or registered in said county.
