To Have and to Hold the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part, not as tenants in common but as joint tenants.

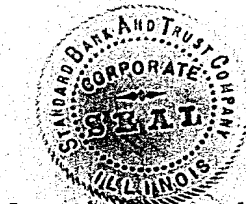
Subject to: General real estate taxes for the year 1972 and subsequent years.
