Lot 13 in Block 4 in Canterbury Gardens Unit No. 1, being a Subdivision of part of the Northwest Quarter of Section 24, Township 20 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois

Together with the tenements and appurtenances thereto to have and to hold the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.
