every power, authority and right it thereunto enabling.

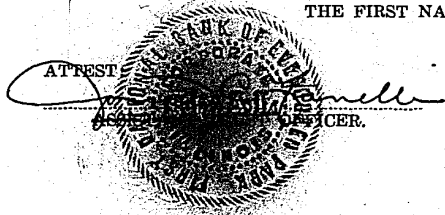
SUBJECT, however, to all taxes and assessments levied after the year 1971; to any unpaid

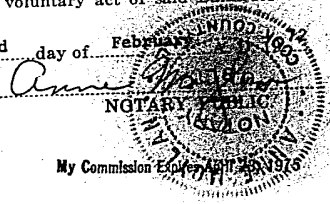
