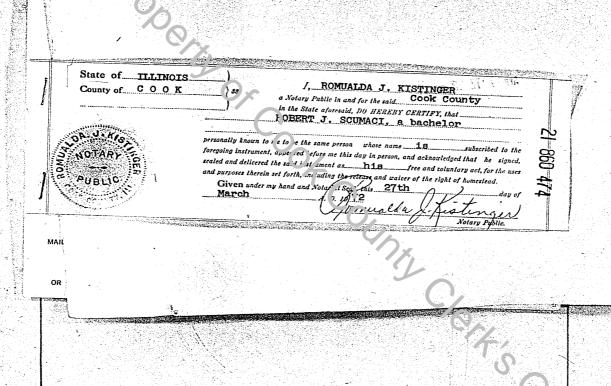

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep-said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) comple within a reasonable time any buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.

- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgap. in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrar s. i. any, and purchase, discharge, compromise or settle any tax lien other prior lien or title or claim thereof, or redeem from any tax r s s t relieve affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes berein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the note to steet the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning payable without notice; at d. with interest thereon at the rate of seven per cent per annum lanction of Trustee or the notes shall never be considered as a wait r of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee or the bulle's of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may decoording to any bill, st. smc to restimate procured from the appropriate public office without inquiry into the accuracy of such bill, statest or estimate procured may tax assessment, sale, forfeiture, tax lien or title or with the root.

- 8. The proceeds of any foreclosure sale of the premises shall be districted and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all uch items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebted ness ad a nal to that evidenced by the note hereby secured, with interest thereon as herein provided; third, all principal and interest remaining unparts, four h, any overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear.

- 12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trur ce e bligated this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or hereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may remire is satisfactory to him before exercising any power herein given.
- 31. Thiste shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidential indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that (il not defense hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a function, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purportix () be executed by a prior trustee hereunder or which conforms in substance with the description herein contained of the principal note and, which purports to be executed by the persons herein designated as the makers thereof, and where the lease is requested of the original trustee and he is never executed a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine print pal note herein described any note which the associated by the persons herein designated as makers thereof.
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have
- been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.
- authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation to an authority as are herein given Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
