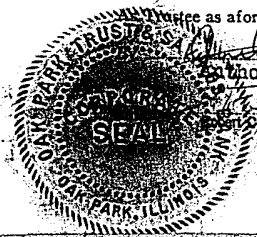
NO TAXABLE CONSIDERATION
