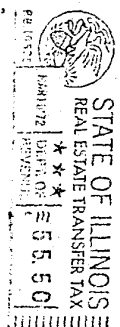

SUBJECT TO: Restrictions and conditions of record.



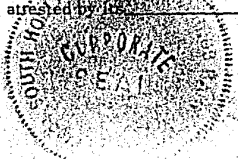
This deed is executed pursuant to and in the exercise of the power and authority granted to and
