GRANTEE all interest in the following described real estate situated in the Village of Hillside, County of Cook, and the State of Illinois to wit:

That part of the East Half of the Southeast Quarter of Section 7, Township 39 North, Range 12 East of the Third Principal Meridian, bounded as follows: On the North and South by lines parallel with and distant 50 feet Northerly and 50 feet Southerly, respectively, measured at right angles from the center line of the main track (now removed) of the Minnesota and North Western Railroad Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Railway Company), as said main track center line was originally located and established over and across said Section 7; and on the East and West by the Southerly extension of the Easterly and Westerly lines respectively, of Lot 46 in Castle Homes Addition to Hillside.

By the acceptance of this conveyance, the Grantees agree for themselves, their heirs and assigns:

- (1) That the Grantor, its employees and nominees, shall have the right to enter the above described real estate until March 31, 1972 for the purpose of removing track facilities and appurtenances from said real estate and from adjoining real estate.
