THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged of destroyed: (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liems or claims for liem one expressly subordinated to the liem hereof; (3) pay when due any indebtedness which may be secured by a liem or charge on the premises superior to the liem to the liem hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (4) complete within a reasonable time any building or buildings now or at any time in process of crection upon said premises; (5) comply with all requirements of law or manifelal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises; (5) comply with all requirements of law or municipal ordinances.
