upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (4) complete within a reason building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law of municipal or respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, and other rhapets algainst the premises when due, and shall, upon writints request, furnish to Trustee or tholders of the note duplicate receipts therefor.
