UNITED STATES MARSHAL'S DEED

THIS INDENTURE, made this 30th day of May A.D., 1972, between John C. Meiszner, United States Marshal for the Northern District of Illinois, and the United States of America.

In pursuance of an order entered on November 1, 1967, by the United States District Court for the Northern District of Illinois, Eastern Division, in a case then pending wherein the United States of America was plaintiff and Sam Mitchell, Vera L. Mitchell, Sam Dale Mitchell, The Chicago Title and Trust Co., Theodore S. Isaacs, Director of the Department of Revenue of the State of Illinois, and Cook County were defendants, Civil Number 62 C 1823, the United States Marshal duly advertised, according to law, the premises hereinafter described, for sale at public auction to the highest bidder for cash at 2:00 p.m. on July 20, 1971, at the Cook County Courthouse, in the City of Chicago, County of Cook, and State of Illinois.

At the time and place appointed for the sale, the United States Marshal offered the premises for sale at public auction to the highest bidder for cash, and received a bid in the sum of fifteen thousand dollars and no cents (\$15,000.00) for the premises, and being the highest bid offered, the United States Marshal accordingly sold to the United States of America, the premises described below.

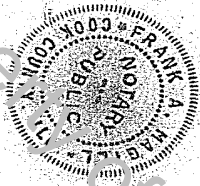
