Together with the tenements and appurtenances thereunto belonging TO HAVE AND TO HOLD the same unto said parties of the second part for use and enjoyment, not in tenancy in common, but in joint tenancy.

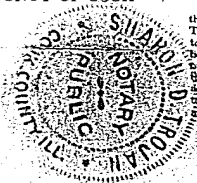
