Lots 16 and 17 in Block 1 in Roth and Gordon's Crawford Church Terminal subdivision in the North East Quarter of Section 15, Township 41 North, Range 13, East of the Third Principal Meridian in Cook County, Illinois.



Together with the tenements and appurtenances therunto belonging.

TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. 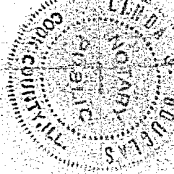
