STEPHEN AND MARY LEWIS BUTLER, his wife, of 570 Jackson of the Village of Glencoe, County of Cook, State of Illinois not in Tenancy in Common, but in JOINT TENANCY, the following described Real Estate situated in the County of Cook in the State of Illinois, to wit:

That part of Lot 2 in Gall's Resubdivision of Lots 7 to 11 inclusive and the Southeasterly 35.6 feet of Lots 6 and 12 in Block 8, except the Northeasterly 200 feet of the Southeasterly 35.6 feet of Lot 6 and also except the Northeasterly 200 feet of Lot 7 and also the Northwesterly 7.4 feet of the Northeasterly 200 feet of Lot 8, all in the Village of Glencoe in Sections 5, 6, 7 and 8, Township 41, Range 13, East of the third Principal Meridian, in Cook County, Illinois according to the Plat thereof recorded November 10, 1914 as Document 5528719, described as beginning at the South East corner of said Lot 2; thence Northerly on the East line of said lot, 266.25 feet; thence Westerly on the Northerly line of said lot 2, 50 feet to a point; thence Southerly in a straight line 235.7 feet to a point on the Southerly line of said Lot 2, 90 feet West from the point of beginning; thence Easterly on the Southerly line of said Lot 2, being on Hawthorne Avenue, 50 feet to the point of beginning in Cook County, Illinois.
