THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destoyed; (3) keep said premises free from mechanic's liens or cliens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) gay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complet within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satiotary to the holders of the note, under insurance poli and payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortary of the second payable, in the second payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortary of the second payable, in case of loss of loss
- as of surance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

  "A mass of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore require of Notageors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior enc mb nees, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax also or forefeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expursor, by dor incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action have a positive thereon at the rate of seven per cent per annum. Insortion of Trustee or holders of the notes shall never be considered as a valver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee or the holes of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, st. em at or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the accuracy of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall the each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of the the interest and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the printipal of the interest, or in case de 'nu' shift occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 8. The proceeds of any foreclosure sale of the premises shall be distracted and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including an analysis of the proceeding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtednes and all the relative provided; blind, all principal and interest thereon as herein provided; blind, all principal and interest therefore as herein provided; blind, all principal and interest tremaining the party of the proceedings as their rights may appear.
- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall be subject and defense which would not be good and available to the party interposing same in an action at law upon the note hereby secured.
- 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable times and coess thereto shall be permitted for that purpose.
- 12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee has bligated to recording this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any action missions hereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may require indimities satisfactory to him before exercising any power herein given.
- 33. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evident, and all debtedness secured by this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evident, and at the request of a type person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all intebut one hereof who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all intebut one hereof the secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor rust excusted successor trustee may accept as the genuine note herein described any note which bears a certificate of identification praporting to be executed by a prior trustee hereunder or which conforms in substance with the described nerein contained of the principal note accusted by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and he have respected and which conforms in substance with the described herein, he may accept as the genuine principal note herein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
  - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have

been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.

IMPORTANT
