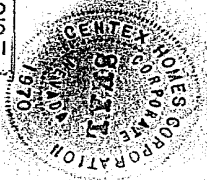

5. Use and occupancy of the premises for single family residential purposes only.

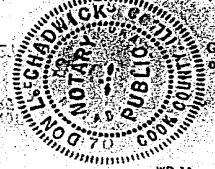
