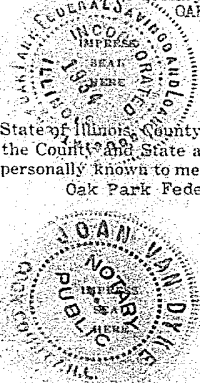
THE GRANTOR OAK PARK FEDERAL SAVINGS AND LOAN ASSOCIATION
