ASSOCIATE JUDGE'S DEED

WHEREAS, Amata Grassi Husen, on the 13th day of June, 1972, in the Circuit Court of Cook County in the State of Illinois, in Case Number 72 CH 2103, entitled Amata Grassi Husen, Plaintiff vs. Solomon Herskovitz and Jenny Herskovitz, Defendants, was granted a Decree providing the specific performance by said Solomon Herskovitz and Jenny Herskovitz, Defendants, wherein said defendants should, within three days from the date of said Decree, execute and deliver to Amata Grassi Husen a warranty deed conveying all of their interest in the following described real estate:

Lot 10 in S. W. Hulls Resubdivision of Lots 14, 15, 18, 19, 22, 23, 26 and 27 in Block 15 in Watson Tower and Davis Subdivision of the West Half of the North West Quarter of Section 6, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

To Have and to Hold the same, with all the appurtenances thereto belonging, to the said Amata Grassi Husen, her heirs and assigns forever.

This Deed is executed and delivered solely in compliance with the Decree of Court hereinabove referred to.
