To Have and to Hold the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part.

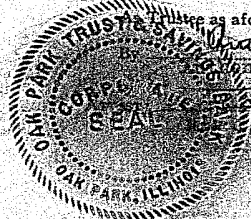
Subject to conditions and restrictions of record; 1971 and subsequent years taxes.
