WARRANTY DEED 21 981 826

THE GRANTOR, VALE DEVELOPMENT COMPANY

a corporation created and existing under and by virtue of the laws of the State of Illinois duly authorized to transact business in the State of Illinois for the consideration of TEN DOLLARS and other good and valuable considerations and pursuant to authority given by the Board of Directors of said corporation, CONVEYS AND WARRANTS unto ROBERT E. HAGGARD AND FRANCES M. HAGGARD, his wife of 1919 Burke Drive of the Village of Arlington Heights, County of Cook and State of Illinois, not in tenancy in common, but in joint tenancy, the following described Real Estate, to wit:

Lot No. 3 in Elk Grove Estate Townhouses of Parcel "G", being a Subdivision in the South Half of Section 29, Township 41 North, Range 11, East of the Third Principal Meridian in Cook County, Illinois, according to the plat thereof recorded October 24, 1969, as Document No. 20995531 and filed with the Registrar of Titles on October 24, 1969 as Document LR2477591.

Subject to:

- (1) General Taxes for the year 1971 and subsequent years.
- (2) Any special taxes or assessments levied for improvements not yet made;
- (3) Easements, covenants, restrictions and conditions of record including those contained in declaration recorded October 24, 1969, as Document Numbers 20995530 and 20995532 and filed in the Office of the Registrar of Titles as Document Numbers 2477590 and 2477592 respectively.
- (4) Building lines, and building and zoning ordinances;
- (5) Subject to the Declarations of Easements and covenants by grantor one dated the 22nd day of October, A.D. 1969, and recorded in the Office of the Recorder of Deeds, Cook County, Illinois, as Document Number 20995530 and filed in the Office of the Registrar of Titles as Document Number 2477590 and the other dated October 23, 1969 and recorded in the Office of the Recorder of Deeds, Cook County, Illinois as Document Number 20995532 and filed in the Office of the Registrar of Titles as Document Number 2477592, which is incorporated herein by reference thereto. Grantor grants to the grantees, their heirs and assigns, as easements appurtenant to the premises hereby conveyed the easements created by said Declaration for the benefit of the owners of the parcels of land herein described. Grantor reserves to itself, its successors and assigns, as easements appurtenant to the remaining parcels described in said Declarations the easements thereby created for the benefit of said remaining parcels described in said Declarations and this conveyance is subject to the said easements and the right of the Grantor to grant said easements in the conveyances and mortgages of said remaining parcels or any of them, and the parties hereto, for themselves, their heirs, successors and assigns, covenant to be bound by the covenants and agreements in said document set forth as covenants running with the land.

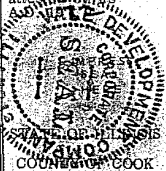
TO HAVE AND TO HOLD the above granted premises unto the said parties of the second part forever, not in tenancy in common, but in joint tenancy.

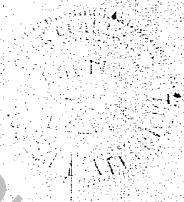
