That part of Block 2, in Valley Lo-Unit Five, being a Subdivision in Section 25, Township 47 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the south line of said Block 2, at a point which is 743.25 feet east from the southwest corner of said Block 2, and running thence east along said south line of Block 2, a distance of 235.67 feet; thence north along a line perpendicular to said south line of Block 2, a distance of 120.50 feet; thence west along a line 120.50 feet north from and parallel with said south line of Block 2, a distance of 235.67 feet to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at said point which is 743.25 feet east from the southwest corner of said Block 2, and thence south along said last described perpendicular line, a distance of 120.50 feet to the point of beginning. together with an undivided 12.15% interest in said Parcel (excepting from said Parcel all property and space comprising the units thereon as defined and set forth in said Declaration of Condominium and survey).

Grantor furthermore expressly grants to the parties of the second part, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and the rights and easements set forth in other Declarations of Condominium Ownership whether heretofore or hereafter recorded affecting other premises in Block 2 in Valley Lo Unit Five Subdivision aforesaid, including, but not limited to, the easements for ingress and egress set forth therein.

This conveyance is made subject to all rights, benefits, easements, restrictions, conditions, reservations and covenants contained in said Declaration, and the grantor expressly reserves to itself, its successors and assigns, the rights, benefits and easements set forth in said Declaration for the benefit of all remaining property described in said survey or said Declaration.

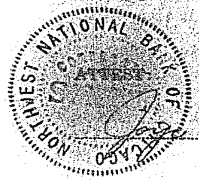
