This Release shall be governed by and construed in all respects in accordance with the law of the State of Illinois.

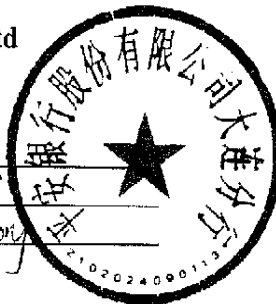


