The Owners further agree that in the event of further violation or default of this agreement on their part, that the Village may terminate the unlawful occupancy of said premises and further initiate prosecution and avail itself of the remedies under the ordinances of the Village of Elmwood Park, at the sole cost and expense of the Owners.

This covenant shall run with the land and be bir.ding upon all successors in title, transferees and all other persons having any interest whatsoever in said real estate. This document shall be recorded by the seller/owner in the Office of the Recorder of Deeds, Cook County, Illinois and a copy of the filed document returned to the Village.

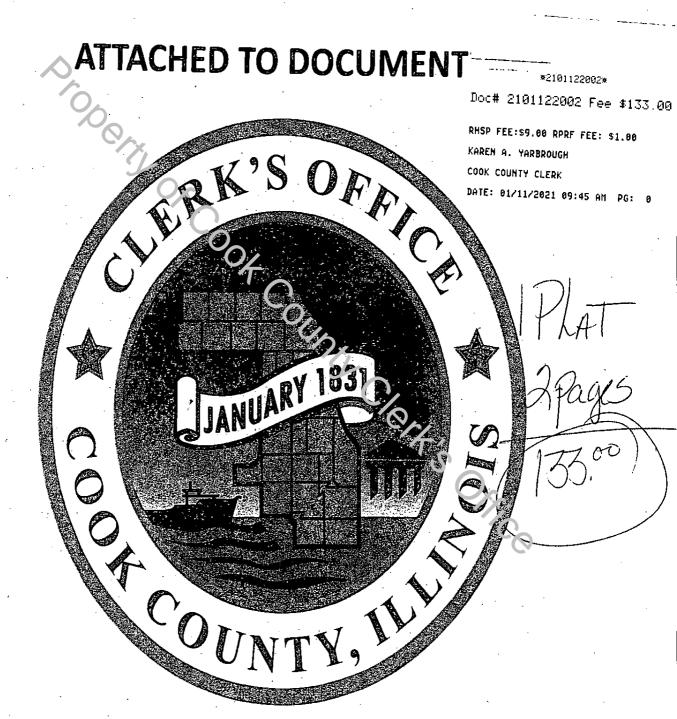
