This Second Amendment to the DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, AND COVENANTS FOR 3240 N. WITNESSETH:

The Declaration was originally recorded with the Cook County Recorder of Deeds on August 18, 1998 as Document No. 98727048 and amended by that certain AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP PURSUANT TO THE CONDOMINIUM PROPERTY ACT FOR 3240 N. SHEFFIELD CONDOMINIUM dated April 8, 2016 and recorded with the Cook County Recorder of Deeds on May 2, 2016 as Document No. 1612334105 (the "First Amendment") (the Declaration and First Amendment are collectively referred to herein as the "Declaration") for the property commonly known as 3240 N. Sheffield, Chicago, Illinois which is legally described on Fishibit A attached to this Second Amendment.

The Association desires to amend the Declaration pursuant to Section 9.01 of the Declaration and Section 27 of the Illinois Condominium Property Act (765 ILCS 605/1 et. seq.) ("Act") to permit residential use of Unit 1;

Section 3.05 of the Declaration. Section 3.06 of the Declaration (as amended by the 1. First Amendment's hereby deleted in its entirety and in its place, Section 3.06 of the Declaration shall read as follows:

Unit as a Residence Only Each Unit shall be used for residential purposes only including, but not limited to, sleeping, cooking, bathing, maintaining a professional library, conducting personal business or professional telephone calls or correspondence from a Unit and any use permitted in the City of Chicago B2-3 zoning classification.
