FIRST MODIFICATION OF MORTGAGE AND ASSIGNMENT OF RENTS AND LEASES

- The Mortgage is hereby modified to reflect as obligations secured thereby and included in the definition of Secured Obligations therein, in addition to any other Secured Obligations desired therein or arising thereunder, the payment to Mortgagee of all indebtedness and performance of all originations evidenced by and arising under that certain promissory note dated as of December 18, 2020, executed by PASS-A-GRILLE REALTY COMPANY and payable to Mortgagee or its order on or before December 31, 2021, in the principal amount of Seven Hundred Fifty Thousand Dollars (\$750,000.00) (which promissory note represents the refinancing of that certain promissory note dated as of September 27, 2019, and secured by the Mortgage), together with interest thereon, and any such indebtedness or other obligations incurred under or in connection with the credit accommodation evidenced by said promissory note, even if not specifically referenced therein.
- The real property and the whole thereof described in the Mortgage shall remain subject to the lien, charge or encumbrance of the Mortgage and nothing herein contained or done pursuant hereto shall affect or be construed to affect the liens, charges or encumbrances of the Mortgage, or the priority thereof over other liens, charges or encumbrances, or to release or affect the liability of any party or
