- (x) acts done or suffered by or judgments against Grantee or anyone claiming under Grantee; and



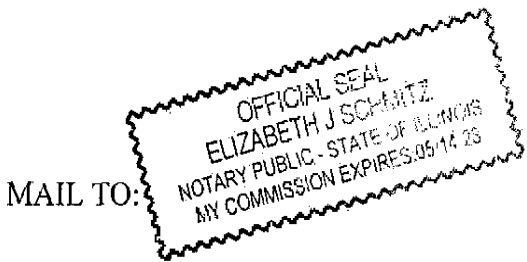
