### Exhibit A

#### Parcel 1:

Lot 10 in George Talafon's resubdivision of lots 1 to 18 and vacated streets and alleys in Block 2 and lots 1 to 11 and vacated streets and alleys in Block 1 all in George Talafon's subdivision of Block 39 in Circuit Court partition of part of Section 31, township 39 north, range 13, east of the third principal Meridian, except that part of lot 10 described as follows:
