This Amendment to the Declaration of Covenants and Easements of 5101 North Clark Condominium Clark a/k/a Carmen Condominium Association is made and entered into this December 30, 2020 by Clark Carmen Condominium Association, with the approval of sixty-seven percent (67%) of the Units of the Association, with due notice to the Mortgagees obtained per Section 27 of the Illinois Condominium Property Act and Article 13, Section 13.7 of the Declaration;

WHEREAS the Board of Directors has called a meeting of the Board to execute the amendment after approval by the Members, and has obtained the consent or approval of sixty-seven percent (67%) of members and/or Unit Owners at a special meeting of the Members duly called for the purpose to approve an amendment to the Declaration to restrict certain activities in units causing nuisance to other units and the Common Elements such meeting of the Board and of the Members called per the terms of the Declaration and Bylaws. with due notice, and notice to the First Mortgagees made, per the terms of the Declaration and Bylaws:

WHEREAS the Unit Owners and/or Members, consenting in favor of this Amendment, having sixty-seven percent (67%) of the Units consenting in favor per Article 13, 8 action 13.7 of the Declaration, and per same, notice required to all Mortgagees, with no formal Mortgagee consent needed.

Clark Carmen Condominium Association hereby amends its Declaration, recorded as Document 0513339013 on May 13, 2005 with the Cook County Recorder of Deeds, as follows, to change its name to **Clark Carmen Condominium Association** as it has been known and incorporated, and with the following additional amendment to the terms of the covenants, with existing text in regular typeface, **new text in bold**, and any text removed shall be shown as stricken through:

ARTICLE 7, Section 7.1 shall have the following added as 7.1(m):

(m) Unit Owners, occupants, their guests and invitees shall not smoke any lighted or burning tobacco, cannabis, or other similar smoking substances within the Units and/or the Common Elements of the Association. This provision shall be construed broadly to

prohibit all forms of smoking tobacco and/or cannabis, including lit, warmed or similar uses that emit smoke, odor, or airborne particles from combustion at the Property. Nothing herein shall prohibit any non-lighted or non-burning use of such substances. This restriction does not limit or prohibit vaporized substances that do not rely upon combustion.

The terms used herein, if not otherwise defined, shall have the same meaning described to them in the Declaration.

The language of this Amendment shall govern any conflicts between this document and the prior Declaration and its amendments.

Except as to the extent expressly set forth herein above, and as amended, the Declaration, By-Laws and Rules and Regulations shall continue in full force and effect without change.

This Amendment shall become effective upon recording.
