Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall not extend or postpone the due date, or change the amount, of the Periodic Payments.

Funds for Ecrow Items. - 6. Occupancy. - 7. Preservation, Maintenance and Protection of the Property; Inspections. 
