The notice shall further inform Borrower of the right to reinstate after acceleration and the right to bring a court action to assert the non-existence of a default or any other defense of Borrower to acceleration and sale. If the default is not cured on or before the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Security Instrument without further demand and reav invoke any other remedies permitted by Applicable Law. Lender shall be entitled to collect all expenses in overed in pursuing the remedies provided in this Section 7, including, but not limited to, reasonable attention, stress and costs of title evidence.
