

If my representations and covenants in Section 1 continue to be true in all material respects, then this Modification Agreement ("Agreement") will, as set forth in Section 3, amend and supplement (1) the Mortgage on the Property, and (2) the Note secured by the Margare. The Mortgage and Note together, as they may previously have been amended, are referred to as the "Loan Documents."  - A. I am experiencing a financial hardship, and as a result, (i) I am in default under the Loan Documents or my default is imminent, and (ii) I to not have sufficient income or access to sufficient liquid assets to make the monthly mortgage payments now or in the ner. nature.
 - B. The Property has not been condemned
 - C. There has been no impermissible change in the ownership of the Property since I signed the Loan Documents. A permissible change would be any transit, that the lender is required by law to allow, such as a transfer to add or remove a family member, spouse or domestic parties of the undersigned in the event of a death, divorce or marriage.
 - D. I have provided documentation for all income with receive (and I understand that I am not required to disclose child support or alimony unless I chose to rely on such it were when requesting to qualify for the Modification Program ("Program")).
 - E. Under penalty of perjury, all documents and information (h) re provided to Lender in connection with this Agreement, including the documents and information regarding my eligibility for the Program, are true and correct.
 - F. If Lender requires me to obtain credit counseling in connection with the Program, I will do so.
 - G. I have made or will make all payments required under a Trial Period Plan.
 - H. I, MICHELLE I. WILLIAMS FKA MICHELLE WILLIAMS-COLSTON, may eccive a discharge in a bankruptcy proceeding after signing the Note and Mortgage/Deed of Trust. I and the Lender acknowle use and agree that this Agreement is not an attempt to collect, recover, enforce, or offset this indebtedness against me personally account affect the discharge of my personal liability, and shall not be construed as a waiver of the discharge or an attempt to review personal liability for this indebtedness. I understand that I am not obligated to enter into this Agreement and that I am entrangement voluntarily and with no coercion or pressure from the Lender, for the sole purpose of retaining the largety. I and the Lender acknowledge and agree that the Mortgage/Deed of Trust is an enforceable lien on the Property, that this Agreement shall not prejudice the lien in any way, and that the Lender's sole recourse is the enforcement of its lien on the Property and any action which may exist in relation to the Property itself.
- 2. Acknowledgements and Preconditions to Modification. I understand and acknowledge that:
 - A. The Loan Documents will not be modified unless and until (i) the Lender accepts this Agreement by signing and returning a copy of it to me, and (ii) the Modification Effective Date, as set fourth in Section 3, has occurred. I further understand and agree that the Lender will not be obligated or bound to make any modification of the Loan Documents if I fail to meet any one of the requirements under this Agreement.

I understand that if I have failed to make any payments as a precondition to this modification under a Trial Period Plan, this modification will not take effect. The first modified payment will be due on 08/01/2020.

- A. The Maturity Date will be 07/01/2060.
- B. The modified principal balance of my Note will include all amounts and arrearages that will be past due as of the Modification Effective Date (including unpaid and deferred interest, fees, escrow advances and other costs, but excluding unpaid late charges, collectively, ("Unpaid Amounts") less any amounts paid to the Lender but not previously credited to my Loan. The Unpaid Amounts include \$2,159.66 of unpaid interest, and \$5,676.45 of pending fees. The new principal balance of my Note will be \$73,296.04 (the "New Principal Balance"). I understand that by agreeing to add the Unpaid Amounts to the outstanding principal balance, the added Unpaid Amounts accrue interest based on the interest rate in effect under this Agreement. I also understand that this means interest will now accrue on the unpaid Interest that is added to the outstanding principal balance, which would not happen without this Agreement.
- C. Interest at the rate of 4.75% will begin to accrue on the New Principal Balance as of 07/01/2020 and the first new monthly payment on the New Principal Balance will be due on 08/01/2020. My payment schedule for the modified Loan is as follows:

- E. If a default rate of interest is permitted under the Loan Documents, then in the event of default, the interest that will be due will be the rate set forth in Section 3.C.

- H. As of the Modification Effective Date, it any provision in the Note or in any addendum or amendment to the Note allowed for the assessment of a penalty for full or partial prepayment of the Note, such provision is null and void.
- I.
