Borrower shall promptly give Lender written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private party involving the Property and any Hazardous Substance or Environmental Law of which the Borrower has actual knowledge. NON-UNIFORM COVENANTS. Borrower and Lenc er further covenant and agree as follows:

- 21. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement in this Security Instrument (but not prior to acceleration under paragraph 17 unless applicable law provides otherwise). The notice shall specify:

- 31. Illinois Mortgag: Foreclosure Law. If any provision in this Security Instrument is inconsistent with my provision of the Illinois Mortgage Foreclosure Law, 735 ILCS 5/15 et seq.
