Such loss reserve shall be non-refundable, notwithsur sing the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings or such less reserve. Lender can no longer require loss reserve payments if Mortgage Insurance coverage (in the amount and for the rood that Lender requires) provided by an insurer selected by Lender again becomes available, is obtained, and Lender requires separately designated payments toward the premiums for Mortgage Insurance. If Lender required Mortgage Insurance as a cordition of making the Loan and Borrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss reserve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between Bo. 10 me, and Lender providing for such termination or until termination is required by Applicable Law. Nothing in this Section 10 after is Borrower's obligation to pay interest at the rate provided in the Note.

- 17. Borrower's Copy. Borrower shall be given one copy of the Note and of this Security Instrument.
- 18. Transfer of the Property or a Beneficial Interest in Borrower. As used in this Section 18, "Interest in the Property" means any legal or beneficial interest in the Property, including, but not limited to, those beneficial interests transferred in a bond for deed, contract for deed, installment sales contract or escrow agreement, the interest of which is the transfer of title by Borrower at a future date to a purchaser.
