TO HAVE AND TO HOLD said premises with the appurtenances upon the trust and for the uses and purposes herein and as set forth in the Trust Agreement.

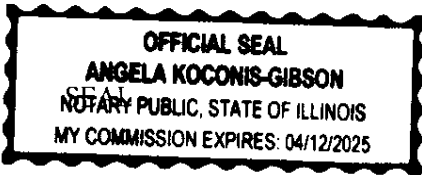

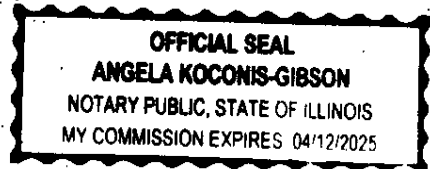

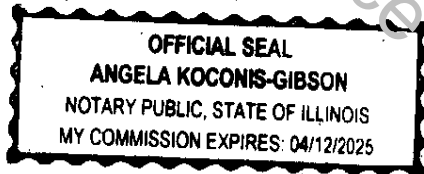
