payment or partial payment if the payment or partial payments are insufficient to bring the Loan current. Borrower shall not, without the express written consent of Lender, after or amend the ground lease. If Borrower acquires fee title to the

Property, the leasehold and the fee title shall not merge unless Lender agrees to the merger in writing.

10. Mortgage Insurance If Lender required Mortgage Insurance as a condition of making the Loan, Borrower shall pay the premiums required to n cintain the Mortgage Insurance in effect. 
