



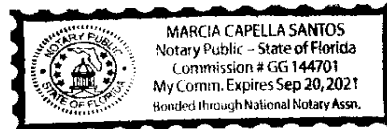

### PARCEL 2:
