Without in any way limiting the generality of the foregoing, Mortgagor covenants and agrees to maintain insurance coverage on the Premises to include: (i) All risk coverage insurance (including vandalism and malicious mischief) for an amount equal to not less than the full replacement cost of the improvements and fixtures located on the Premises, written on a replacement cost basis and with a replacement cost endorsement (without depreciation) and an agreed amount endorsement pertaining to the co insurance clause, (If at any time a dispute arises with respect to replacement cost.
