- that if I have failed to make any payments as a precondition to this modification under a Trial Period Plan, this modification will not take effect. The first modified payment will be due on 05/01/2021.
- A. The Maturity Date will be 04/01/2051.
- B. The modified principal balance of my Note will include all amounts and arrearages that will be past due as of the Modification Effective Date (including unpaid and deferred interest, fees, escrow advances and other costs, but excluding unpaid late charges, collectively, ("Unpaid Amounts") less any amounts paid to the Lender but not previously credited to my Loan. The Unpaid Amounts include \$4,036.62 of unpaid interest, and \$7,425.32 of advanced escrows. The new principal balance of my Note will be \$102,057.40 (the "New Principal Balance"). I understand that by agreeing to add the Unpaid Amounts to the outstanding principal balance, the added Unpaid Amounts accrue interest based on the interest rate in effect under this Agreement. I also understand that this means interest will now accrue on the unpaid Interest that is added to the outstanding principal balance, which would not happen without this Agreement.
- C. Interest at the rate of 3.25% will begin to accrue on the New Principal Balance as of 04/01/2021 and the first new monthly payment on the New Principal Balance will be due on 05/01/2021. My payment schedule for the modified Loan is as follows:

I understand that if I have a pay option adjustable rate more gage loan, upon modification the minimum monthly payment option, the interest-only, or any other payment options will not onger be offered. The monthly payments, as described in the above payment schedule for my modified Loan, will be the minimum payment that will be due each month for the remaining term of the Loan. - H. As of the Modification Effective Date, if any provision in the Note or in any addendum or amendment to the Note allowed for the assessment of a penalty for full or partial prepayment of the Note, such provision is null and void.
- I.
