- 4. That on or about January 21, 2021, Subcontractor did make a final delivery to the Premises various windows, doors and other building materials and supplies as ordered of the General Contractor. Such order was the last order placed by the General Contractor with the Subcontractor.
- The Subcontractor has fulfilled all of its obligations under its Contract with the General 5. Contractor.

That there is presently due and owing to the Subcontractor under its said Contract with the General Contractor, including all extras, and after allowing all credits justly due, the sum of Fifty-Three Thousand Ninety-Nine and 13/100 Dollars (\$53,099.13) for which, with interest, the Subcontractor claims a lien on and against the Premises and all improvements thereon and on the moneys or other considerations due or to become due from the Owner under the aforesaid contract, against said General Contractor and Owner, and against the creditors and assignees and personal and legal representatives of each of the foregoing.
