#### MEMORANDUM OF LEASE

This Memorandum of Lease (this "Memorandum") is made this ## day of \_\_\_\_\_\_\_, 2021, between ORLAND COMPANY TRUST, an Illinois business trust ("Landord"), and ADVANCE STORES COMPANY, INCORPORATED, a Virginia corporation ("Tenant").

### WITNESSETH

Landlord and Tenant have entered into a Lease (the "Lease") dated May 4, 2021, whereby Landlord has leased to Tenant that certain premises located on that certain real property, located in Cook County, State of Illinois (the "Property"), the legal description of which Property is set forth on Exhibit "A" attached hereto. - V. <u>Conflicts with Lease</u>. This Memorandum is solely for notice and recording purposes and shall not be construed to alter modify, expand, diminish or supplement the provisions of the Lease.
