This Loan Modification Agreement (the "Agreement") is made on April 28, 2021, between RICK W CINQUEMANI ("Borrower(s)") and Fifth Third Bank, National Association ("Lender").

The parties agree that the Maturity Date of the Note and Security Instrument is extended to 05/01/2051. Borrower(s) acknowledge that extension of the Maturity Date does not extend the term of coverage of any credit life or disability insurance beyond the original loan term.

Borrower(s) promise(s) to pay to the order of Lender the Interest Bearing Principal Balance, plus interest thereon to the order of the Lender. Interest will be charged on the Interest Bearing Principal Balance at a [modified] yearly rate of 3.25% from 05/01/2021. The Borrower promises to make monthly payments of principal and interest due under the Note of One Thousand Eighty-Four and 19/100 (\$1,084.19) beginning on 06/01/2021, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.


