SUBORDINATION OF MORTGAGE

THE SUBORDINATION OF PACATGAGE dated May 10, 2021 is made and executed among Cornerstone National Bank & Trust Company ("Mortgage: Subordinating Bank"); and Cornerstone National Bank & Trust Company, Its Successors and/or Assigns ("Lender").

SUBORDINATED INDEBTEDNESS. Montgage has extended the following described financial accommodation(s) (the "Subordinated Indebtedness") to Timothy B. Nott at a nd Susan E. Nottoli ("Borrower/Mortgagor").

A Home Equity Credit Agreement and Discourse 10/20 in the sum of \$100,000.00 dated December 22, 2016 with a Maturity of December 22, 2046, in farms of Cornerstone National Bank and Trust Company ("Mortgagee").

SUBORDINATED MORTGAGE. The Subordinated Indebtedness is secured by a Mortgage dated December 22, 2016 and recorded January 9, 2017, as Document Number 1700955008, from Paor gagor to Mortgagee (the "Subordinated Mortgage"), on certain premises in Cook County, Illinois.

REAL PROPERTY DESCRIPTION. The Subordinated Mortgage covers the following real property located in McHenry County, State of Illinois:

Lot 2 in Bartel's Resubdivision of Lots 15, 16, 17, 18, 24 and 25, in Joel Wood's Subdivision of Block "Z" in Palatine, in the East ½ of the Northwest ¼ of Section 14, Township 42 North, Range 10, East of the Third Principal Meridian, in Cook County.

The Real Property or its address is commonly known as 308 North Fremont Street, Palatine, IL 60067 The Real Property tax identification number is 02-14-303-009-0000.

NOW THEREFORE THE PARTIES TO THIS SUBORDINATION STATE THE FOLLOWING:

SUBORDINATION. The Subordinated Mortgage and the Subordinated Indebtedness secured by the Subordinated Mortgage is and shall be subordinated in all respects to the Lender's Lien and the Superior Indebtedness, and it is agreed the Lender's Lien shall be and remain, at all times, prior and superior to the lien of the Subordinated Mortgage. Furthermore, Lender is about to lend to Borrower Two Hundred Thirty Thousand Dollars and 00/100 (\$230,000.00) to pay the indebtedness of Borrower to Lender (or other first mortgage to be paid off) and to obtain the release of the first mortgage in favor of Lender and in connection therewith, Borrowers shall give to Lender a Mortgage to secure the loan in the amount of \$230,000.00 and dated within 30 days of May 10, 2021.

DEFAULT BY BORROWER. If Borrower becomes insolvent or bankrupt, this Subordination shall remain in full force and effect.

MISCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Subordination:

Existing First Mortgage: If the existing first mortgage in favor of Lender (or other lending institution), as described above, is released in full, then the mortgage in favor of Subordination Bank, shall be and is hereby subjected and subordinated and shall become in all respects subordinate and junior to the lien of the mortgage given by Borrower to Lender as collateral for the loan to pay off the existing first mortgage and to replace it with a mortgage in favor of Lender.

Principal Increases: Lender agrees to not increase the principal sum under the mortgage to which the Subordinating Bank hereby subordinates or to make additional advances of principal under the mortgage, without the written consent of Subordinating Bank. Notwithstanding, Subordinating Bank acknowledges that Lender has a right to interest on the unpaid principal balar ce of the mortgage, penalties for nonpayment thereof, and a right to recover amount expended for payment of real estate taxe, he zard insurance and costs incident to foreclosure and such items are included in this subordination.

Amendments: What is written in this Subordination is Mortgagee's entire agreement with Lender concerning the matters covered by this Subordination. To be effective, any change or amendment to this Subordination must be in writing and must be signed by whoever will be bound or obligated by the change or amendment.

Authority: The person who signs this Sucordination as or on behalf of Mortgagee represents and warrants that he or she has authority to execute this Subordin tion and to subordinate the Subordinated Indebtedness and the Mortgagee's security interest in the Borrower's property, it as y
